One important document available on the site is the "Bioterrorism Readiness Plan: A Template for Healthcare Facilities," a set of guidelines for managing patients with diseases that may be related to bioweapons.<sup>8</sup>

Guidelines for responding to both genuine anthrax attacks and anthrax hoaxes have been published by the CDC in *Morbidity and Mortality Weekly Report*.<sup>1</sup>

The August 6, 1997 issue of *JAMA* was dedicated to bioterrorism and contains a valuable review by Franz et al<sup>3</sup> of the signs and symptoms of diseases with possible bioweapons significance. The July-August 1999 issue of *Emerging Infectious Diseases* was also dedicated to coverage of bioterrorism, focusing on the National Symposium on Bioterrorism held at Johns Hopkins University in February 1999.<sup>9</sup> A recent review article in the *New England Journal of Medicine* contains additional in-depth information about anthrax.<sup>10</sup>
